- in accordance with § 79 (2) of the Regulation the Bank will not submit the separate quarterly report and the consolidated quarterly report for Q4 of 2019 and Q2 of 2020;
- in accordance with § 62 (1) of the Regulation the Bank will not submit separate quarterly reports, and consolidated quarterly reports will contain quarterly financial information of the Parent Company;
- consolidated semi-annual report for HY2020 will contain half-year condensed separate financial statements based on, in the scope and in accordance with the § 62 (3) and (5) of the Regulation.
