



List of shareholders with at least 5% voting rights at the Extraordinary General Meeting of Alior Bank S.A. convened to 21 April 2017

Contents of the report: The Management Board of Alior Bank S.A. (“the Bank”) hereby publishes the list of shareholders with at least 5% voting rights at the Extraordinary General Meeting of Alior Bank S.A. convened to 21 April 2017:

1. Powszechny Zakład Ubezpieczeń SA with its registered office in Warsaw and its subsidiary Powszechny Zakład Ubezpieczeń na Życie SA, PZU Specjalistyczny Fundusz Inwestycyjny Otwarty UNIVERSUM and PZU Fundusz Inwestycyjny Zamknięty Aktywów Niepublicznych BIS 2, vested with 37.773.265 votes from the shares held, reflecting 49,06 % votes at the said Meeting and 29,22 % of the total number of votes;
2. AVIVA Otwarty Fundusz Emerytalny AVIVA BZ WBK with its registered office in Warsaw vested with 11.562.000 votes from the shares held, reflecting 15,02 % votes at the said Meeting and 8,94 % of the total number of votes;
3. European Bank for Reconstruction and Development with its registered office in London, vested with 6.247.173 votes from the shares held, reflecting 8,11 % votes at the said Meeting and 4,83 % of the total number of votes.
4. Nationale-Nederlanden Otwarty Fundusz Emerytalny with its registered office in Warsaw vested with 5.700.000 votes from the shares held, reflecting 7,40 % votes at the said Meeting and 4,41 % of the total number of votes;
5. PKO BP Bankowy Fundusz Emerytalny with its registered office in Warsaw vested with 4.798.565 votes from the shares held, reflecting 6,23 % votes at the said Meeting and 3,71 % of the total number of votes;
